


Reasons for increase in the number of violence: The increase in the number of records in violence is due to prevalence of violence registration centers, police and justice law enforcement agencies implementing non-violence law and increase in the awareness of men and women of their rights.

Health Facilities in the Country

According to the data collected from health sector during the 3rd quarter of 2019 shows that there were 182 governments and 450 private hospitals in the country. There is an increases in the government and private hospitals by 6.4 and 23.6 percent respectively compared to the 3rd quarter of 2018.

There were 561 comprehensive health centers, 993 basic health centers and 1,101 sub health centers in the 3rd quarter of 2019, compared to the 3rd quarter of 2018 the comprehensive health centers and sub health centers increased by 28.4 and 0.5 percent respectively and there is a decline of 0.2 percent in the number of basic health centers.







Foreign Trade

Exports, Free on Board (FOB)

The officially recorded exports of goods were around US\$ 208.8 million during the third quarter of 2019, which does not include smuggling and re-export. The registered exports in the third quarter of 2019 compared to the third quarter of 2018 decreased by 20.3 percent.

It is worth mentioning that in the third quarter of 2019 exports of dry and fresh fruits constitutes 42.3 percent of exports and that of medical herbs constitute 22.5 percent of the total exports of the country. In the third quarter of 2019, exports of minerals compared to the third quarter of 2018 decreased by 26.0 percent.

It has to be mentioned that during the third quarter of 2019, the value of re-export is US\$ 1.5 million from all boundaries of Afghanistan.

Imports, including Cost Insurance Freight (CIF)

The officially recorded import of goods in the third quarter of 2019 was US\$ 1591.2 million excluding smuggled and duty-free goods.

The registered imports in the third quarter of 2019 compared to the third quarter of 2018 decreased by 10.5 percent (from US\$ 1777.3 million to US\$ 1591.2 million). The data shows that the main imports includes petroleum and lubricants, machinery, vehicles and spare parts, vegetable oil, metal products and fabric which constitutes 49.7 percent of total imports.

Duty free imports

The total duty free imports during the third quarter of 2019 was US\$ 558.8 million as compared to US\$ 416.9 million in the third quarter of 2018, which shows an increase of 34 percent.



National CPI

The inflation rate measured by the overall consumer price index (CPI) for the country was 1.5 Percent in third quarter of 2019 compared to the second quarter of 2019. The inflation compared to third quarter of last year increased by 2.5 Percent.

In the third quarter of 2019 the decreases was in fruits and vegetable prices in food items and housing and communication in non-food items.

Food Prices Index

The national overall price index for food items in the third quarter 2019 compared to the second quarter of 2019 had decreased by 2.4 Percent. The main contributory factors was decrease in vegetable prices by 15.9 percent and fruits prices by 9.9 percent. The highest decrease of food items in country was in Takhar province by 6.4 percent.

Non-Food Prices Index

The national non-food prices decreased by 0.6 percent in third quarter 2019 compared to the second quarter of 2019. The decrease was mainly in housing prices by 2.1 percent and communication by 2.3 percent.



Graph 11-2: National CPI & Kabul CPI Quarterly Inflation (% Change to Previous Quarter)


